#### Placing an order

All order forms confirmed by the purchaser with a click constitutes an irrevocable undertaking by the client and can only be revoked in conformity with the clause "Right of Retraction" below.

#### Confirmation of the order

The order becomes a contractual undertaking only when confirmed by P & O WRIGHT INTERNATIONAL.

The client will receive by fax, mail or E-mail a confirmation of the order giving all the relevant details (products ordered, prices, delivery times, delivery costs tax etc.)

P & O WRIGHT INTERNATIONAL. reserves the right not to accept an order for whatever reason, especially for reasons of non availability, or for reasons relating to the order itself.

#### Price - Invoice

The price determined at the time of order is firm and definitive. It does not include delivery costs. These are shown on the confirmation of the order.

For all deliveries outside the European Union any Customs duty or taxes due at the time of importation into the country of delivery are at the cost of the client.

All formalities relating to importation of the product are also the responsibility of the client.

## Means of payment

The client is free to pay

- Either by credit or debit card as indicated on the site.
- Or by PAYPAL

Each order will be the object of an invoice issued by P & O WRIGHT INTERNATIONAL. at the time of delivery.

## **Ownership** rights

The products ordered remain the property of P & O WRIGHT INTERNATIONAL. until full payment of the order.

### **Delivery**

The delivery docket provided by the transporter, dated and signed by the client, constitutes proof of delivery.

At the time of delivery, the client should verify the content and the conformity of the delivery and the condition of the products.

In the event of late delivery, partial or total loss, damage or any other problem, it is up to the client to draw the problem to the attention of the transporter. The responsibility of P & O WRIGHT INTERNATIONAL. cannot be invoked in any way.

For these reasons P & O WRIGHT INTERNATIONAL. strongly recommends that the client verify carefully the state of the products delivered before signing the receipt.

If the client observes any anomaly, he should refuse the delivery or state in writing his reservations and date and sign them. These should be sent by registered mail to the transporter within 3 days. A copy of this mail should be sent to P & O WRIGHT INTERNATIONAL.

If the wrong product(s) are sent, the client must return the said product (s) within 7 days to P & O WRIGHT INTERNATIONAL. They should be sent without having being opened and in their original packaging and with the relevant accompanying documents.

As soon as the returned products have been received in good condition P & O WRIGHT INTERNATIONAL. will send at its own expense the product(s) originally ordered.

# **Right of retraction**

In addition to any guarantees offered by the brand, the client has 7 working days from the day of delivery of the product(s) to return the product(s) at his cost for exchange or reimbursement if for any reason the products are not to his liking.

The product must be in same condition and in the same packaging in which it was delivered. It must not have been used nor have been subject to any deterioration however minimal and must be perfectly clean.

There is no penalty for exercising this right of retraction except those related to the costs of returning the product.
